**WAIVER OF PERSONAL APPEARANCE**

The undersigned defendant, having been advised of his/her right to be present at all stages of the proceedings, including when the case is set for trial, when a continuance is ordered, when a plea is entered at the time of trial or sentencing, when a motion for reduction of bail or for a personal recognizance release is heard, when a motion to reduce sentence is heard and when questions of law are presented to or considered by the court, hereby requests that the court proceed during every absence of his/hers which the court may permit pursuant to this waiver; and hereby agrees that his/her interests will be deemed represented at all times by the presence of his/her attorney the same as if the defendant his/herself were personally present in court and further agrees that notice to his/her attorney that his/her presence in court on a particular day at a particular time as required will be deemed notice to him/her of the requirement of his/her appearance at the time and place.

**CONSENT TO ENTRY OF PLEA OF GUILTY BY COUNSEL**

- \_\_\_\_\_ 3. I understand that as to the misdemeanor charges, I have the right to a speedy, public jury trial on these charges. At that trial, I would be presumed innocent, and I could not be convicted unless 12 impartial jurors were convinced of guilt beyond a reasonable doubt. At the trial, I would have the right to confront and to cross-examine all witnesses testifying against me. I would also have the right to have the court issue subpoenas to bring into court all witnesses and evidence favorable to me, at no cost to me.
- \_\_\_\_\_ 4. I understand that I have the right to remain silent, and not incriminate myself, and the right to testify in my own behalf. I understand that by pleading guilty or no contest, I am incriminating myself.
- \_\_\_\_\_ 5. Understanding all this for all charges pending against me, I give up the following rights:
