As part of, and an inducement to, the agreement to enter into this voluntary agreement, both parties acknowledge that enforcement hereof is NOT through law enforcement, but rather through the filing of an application in the Superior Court for enforcement of a court order (see CCP §§ 177.5, 1209). This order is NOT entered into the California Restraining and Protective Order System (CARPOS) through the California Law Enforcement Telecommunications System (CLETS) and is not separately enforceable through law enforcement. Violation of this stipulated personal conduct order may result in the imposition of monetary sanctions and a finding of contempt. In addition, continued or egregious violation of this order may result in the ex parte issuance of a formal temporary civil (CCP §527.6), domestic (Family Code § 6380) or elder (W&I Code § 15657.03) restraining order, which would be transmitted to CLETS and subject to law enforcement involvement.
