The Court has read and considered the "Second Supplement" filed on March 28, 2019, to the amended accounting filed on January 16, 2019. The Court preliminarily notes that the "Second Supplement" should have been titled an amendment, as it includes amended accounting schedules that are meant to supersede the schedules previously filed. The Court also requests that, in future accountings, when amended summaries of account or schedules are required, Conservators and their counsel file only the summaries and schedules that actually were amended and not refile the entire accounting to make isolated corrections. Specifically, in the instant case, Conservators were required to file only the following items as part of the instant supplement/amendment: an amended summary of account, a schedule of additional property received during the accounting period, and an amended schedule E (i.e., three pages). Substantively, the "Second Supplement" resolves the issues with the accounting that were described in the minute order dated March 22, 2019.

However, the amended schedule G included in the "Second Supplement" highlights a new issue. In this amended schedule G, Conservators claim a credit of \$961.92 "because of accounting rules only" and state there has been "[n]o actual loss to [the] estate." (This credit also is reflected in the amended summary of account.) This is not the proper way to account for the balance of the CDs in the Edward Jones account as of the end of the accounting period. The Court questions whether fees or commissions have been paid in connection with the CDs. The Court notes a "Change in Value" of the Edward Jones account of -\$166.93 for the one-month period reflected on statement dated September 29 through October 26, 2018. Appearance required to address this issue.

The Court also has read and considered the supplement filed on March 28, 2019, to the petition for attorney fees and costs filed on November 29, 2018. The supplement seeks an additional \$1,170.00 in attorney fees for services between March 21 and March 27, 2019. The supplement brings counsel's request for attorney fees for preparing the instant accounting and appearing at hearings thereon, as well as handling related impacts on the inventory and appraisal and bond amount, to a total of \$13,320.00. Reduction of this total amount, as well as reduction of the amount counsel seeks in cost reimbursement, will be discussed at the hearing.

Finally, the Court has read and considered the amended application for an order increasing bond that was filed on March 28, 2019. The Court questions why Conservators included the balance of cash in the blocked account when calculating bond. The Court also does not understand Conservators' explanation of how they calculated probable annual gross income. The cost of recovery cannot be calculated until these other figures are determined.
