As Conservators acknowledge, bond previously was fixed at \$210,000.00 by order dated September 20, 2017. Bond must now be increased by \$102,575.97 to cover the difference. Conservators incorrectly assert that no increase in bond is required because there is a blocked account; in doing so, they overlook the fact that the funds in the blocked account were excluded from the aforementioned calculation. The Court intends (1) to grant the amended application for an order increasing bond, as amended by the "Third Supplement to Account and Report of Conservators," to the extent bond will be increased and (2) to order the increase to be in the amount of \$102,575.97.
